- The 44th Annual General Meeting of the Members of the Company is scheduled to be held on Saturday, July 20, 2019 at 11.30 a.m. at S.M. Joshi Socialist Foundation (S M Joshi Hall), S. No. 191/192 Navi Peth, Ganjave Chowk, Near Patrakar Bhavan, Pune 411030.
- Pursuant to Regulation 42 of the SEBI LODR Regulations, this is to inform you that Register of Members and Share Transfer Books of the Company shall remain closed from Saturday, July 13, 2019 to Saturday, July 20, 2019 (both days inclusive) for the purpose of declaration of Dividend and Annual General Meeting.

Pursuant to provisions of Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended by the Companies (Management and Administration) Amendment Rules, 2015 and Regulation 44 of the LODR Regulations, 2015, the Company is pleased to provide to the Members e-voting facility through the National Securities Depository Limited (NSDL) to exercise the right to vote on resolutions proposed to be considered at the 44th Annual General Meeting and the business may be transacted through e – voting facility.

The Cut-off date has been fixed as Friday, July 12, 2019 for determining the eligibility of the Members to vote by remote e-voting or by polling paper at the Annual General Meeting.

The remote e-voting period commences on Wednesday, July 17, 2019 at 9.00 a.m. and ends on Friday, July 19, 2019 at 5.00 p.m. Request you to take this on record.
