Clarification on total number of shareholders under promoter and promoter group: As on 30 September 2018 as per the Register of Members, the total number of shareholders under the Promoter and Promoter Group are 32. Based on email dated 21 January 2016 and 15 July 2016 received from BSE, the total number of individual promoters are revised to 15 instead of 27 in the Table I and II by consolidating different folios on the basis of same PAN. As such total number of shareholders under promoter and promoter group in the Table I and II are appearing as 20. (15 - individual promoters and 5 - Bodies Corporate). Further as on 30 September 2018 as per the Register of Members, the total number of public shareholders are 34254.
