1. Clarification on total number of shareholders under promoter and promoter group:

As on 30 June 2024 as per the Register of Members, the total number of shareholders under the Promoter and Promoter Group are 28. (23 folios of individual promoters and 5 folios of Bodies Corporate).

Based on email dated 21 January 2016 and 15 July 2016 received from BSE, the total number of individual promoters are revised to 13 instead of 23 in the Table I and II by consolidating different folios on the basis of same PAN.

As such total number of shareholders under promoter and promoter group in the Table I and II are appearing as 18. (13 - individual promoters and 5 - Bodies Corporate).

Further as on 30 June 2024 as per the Register of Members, the total number of public shareholders are 109441. The different folios of public shareholders are consolidated on the basis of same PAN, pursuant to the circular SEBI/HO/CFD/CMD/CIR/P/2017/128 dated 19 December 2017. As such, the total number of public shareholders appearing in table I and III are 107305.

In view of aforesaid revision in disclosure, the total number of shareholders of the Company are appearing as 107323 instead of 109469.
