Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 including amendments thereunder read with the SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13<sup>th</sup> July 2023, this is to inform you that:

1. The present term of Mr. Atul Kirloskar (DIN 00007387) as the Chairman and Non-Executive Director of the Company, is valid upto 31<sup>st</sup> March 2024. Based on the recommendation of the Nomination and Remuneration Committee, the Board of Directors in the meeting held on 6<sup>th</sup> March 2024, has considered and approved re-appointment of Mr. Atul Kirloskar as a Non-Executive Director and Chairman, with effect from 1<sup>st</sup> April 2024 for a term of 2 (Two) years, subject to the approval of the members of the Company. The Board has approved obtaining such approval of the members of the Company by Postal Ballot pursuant to Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014, including amendments thereunder. The Board has further considered that Mr. Atul Kirloskar shall continue as a Non-Executive Director of the Company with effect from 1<sup>st</sup> April 2026 upon expiry of the aforesaid term of 2 (Two) years.

Mr. Atul Kirloskar (DIN 00007387) and Mr. Rahul Kirloskar (DIN 00007319), being brothers, are related to each other and Mr. Atul Kirloskar and Ms. Gauri Kirloskar (DIN 03366274), being father and daughter are related to each other.

Mr. Atul Kirloskar (Age 68), began his career in manufacturing processes and dealership management with the erstwhile Kirloskar Cummins Limited (now Cummins India) & Cummins Diesel Sales & Service India (CDS&S) in 1978. He moved to Kirloskar Oil Engines Limited in 1984, and worked in various leadership positions and is currently the Chairman of the Company.
